SUBJECT: Consideration of Memorandum of Understanding with the Bonita Museum

and Cultural Center for an Audio-Visual Display

SUMMARY

In February 2023, the Authority received a proposal from the Bonita Historical Society for a potential collaboration effort. The Bonita Museum and Cultural Center houses the Bonita Historical Society (Museum) and currently has over 2,000 objects in its collection from the region. It is the largest museum in South Bay dedicated to documenting the art, history, and culture of the Sweetwater Valley.

The Museum is looking for sponsorship and funding to support a display that shares the historical significance of the Authority, its dam, and the impacts of water in the region. Attached is a copy of the proposal for the Board's consideration. The proposal contained two components:

Item 1: An interactive virtual display. This display would include interactive webbased pieces, historical videos, and a watershed model.

Item 2: An interactive garden stressing sustainability.

At its March 22, 2023 meeting, the Board directed staff to present a cost proposal for Item 1 identified in the Museum's proposal; and to facilitate a discussion with the Water Conservation Garden regarding the possibility of creating a satellite conservation garden at the Museum.

Staff from the Museum worked with its Board and submitted a detailed proposal for consideration. Authority staff contacted Alden Communications for a quote/project proposal. Authority staff previously worked with Alden Communications on the display created for the Living Coast Discovery Center. Alden Communications provided a proposal for the technical piece of the display for the Museum. This would include the interactive touchscreen component, coding, design, and creation of the digital component of the interactive portion of the display. Hardware would need to be provided and has been added to the table below, that details the costs from the proposals:

Item 2 of the proposal directed staff to facilitate a discussion with the Water Conservation Garden and explore creating a satellite garden. Museum staff are working with the Water Conservation Garden, had a meeting on April 25, 2023, and toured the Water Conservation Garden.

At its April 24, 2023 meeting, the Board directed the General Manager to negotiate a Memorandum of Understanding (MOU) with the Museum regarding the interactive virtual display and request funding from the County of San Diego for part of the work. The draft MOU is provided as Attachment 1 for the Board's consideration.

PAST BOARD ACTION
