Consideration to Approve a Three-year Software License Renewal for the Esri Small Utility Agreement

RECOMMENDATION

Staff recommends that the Governing Board approve a three-year License Renewal for the Small Utility Agreement with Environmental Systems Research Institute, Inc. in the amount of \$87,900.00.

OVERVIEW

The Environmental Systems Research Institute, Inc.'s Small Utility Enterprise Agreement (Esri) requires a license renewal to utilize its system. The proposed agreement renewal will allow staff continued use of the Authority's Geographic Information Systems (GIS) provided by Esri. GIS is a tool that helps staff document the location and status of the Authority's distribution system through maps and databases. The tool also assists in making decisions regarding the maintenance of the Authority's systems and informing internal and external stakeholders about the system and spatially related data. The recently developed Outage Map on the Authority's website is an example of an application that runs on GIS to assist customers in determining if a specific address is affected by a water outage. Internally, staff used GIS to locate underground facilities and determine the connections between facilities to perform maintenance.

The Authority has licensed the Esri software called ArcGIS Enterprise as the current GIS system for the Authority's use since the early 2000's. The Authority has been renewing the Esri agreement each year, and this year, the agreement is over \$75,000, requiring Board approval. This renewal provides the Authority with a three-year license agreement and daily support services. Staff's operational needs are currently met by Esri and alternative similarly priced options are not readily available.

FISCAL IMPACT

The FY 2023-24 Budget Operating Expense line item 10-60-600-5676 – IS Equipment Company-wide includes funding to cover the cost of year one of the annual software license and support annual renewal. Staff will propose sufficient funding for these services in the FY 2024-25 and FY 2025-26 Budgets. The cost for the three-year license renewal will be paid annually in the following amounts:
